

Fuel Up Promotion

Terms and Conditions

Promotion Name: JAA Fuel Up Promotion

Promotional Period: July 1 - December 7, 2024

How to Qualify:

To become eligible for this promotion, new and existing JAA members must purchase, renew or upgrade a JAA membership package; or sign up for an individual JAA Advance Card and use J\$10,000 or more worth of fuel within any given month during the promotion period.

Eligible participants:

The JAA Fuel Up promotion is open to:

- All new and existing JAA members
- o All JN Group Members that owns and operate a vehicle.
- o All JN Group Staff members that owns and operate a vehicle.
- The motoring public.

Criteria

Members are eligible to be a monthly or grand prize winner once any of the criteria is met.

- Purchase of a Gold or Platinum or Black card membership package.
- o Renewal of a Gold or Platinum or Black card membership package.
- Upgrade from:
 - Silver membership to a Platinum or Black membership package
 - Gold membership to black membership package
 - Platinum membership to Black membership package
- Sign up for an individual Advance Card with a minimum of J\$10,000
- An accumulated use of J\$10,000 or more from an individual Advance Card

Each entry is valid for the monthly and grand prize. Reward/Benefits:

Method of selection of winners for monthly and grand prize:

- 1. A database of eligible members will be compiled and shared with JN Internal Audit Department for verification and the electronic selection of potential winners. Members will be eligible for one entry in the grand prize draw once they meet the eligibility criteria.
- 2. In total, there will be six (6) monthly draws and one (1) grand prize draw. The potential winners will be contacted by telephone, notified of the prize they have the chance to win and required to complete the test of skill to win it.
 - a. The potential winner will be asked to give the name of the promotion or state the company's tagline. The potential winner will be required to say "JAA Fuel Up Promotion" which is the name of the promotion or "Keeping You Mobile" which is JAA's tagline.
 - b. Each potential winner will have one chance to answer correctly.
 - c. Upon successful recitation of the name of the promotion or JAA tagline, the potential winner would have completed the test of skill and be considered a winner.

A failed attempt is when the phone rings without an answer, goes to voicemail, is busy or is answered by someone other than the recipient that JAA is trying to contact. If no winners are identified, JAA has the right to retain the prizes.

- 5. After the winners are identified, JAA will make the necessary arrangements to have the prize/s disbursed to the winner.
- 6. A representative from the Betting, Gaming and Lotteries Commission ("the BGLC") reserves the right to attend the draw and a member from the JN Group Internal Audit Department will oversee the drawing of prizes in the Promotion.
